# Base Realignment and Closure (BRAC)

The Base Realignment and Closure (BRAC) process is ongoing within DoD's current authorities, and the Administration continues to ask for a Congressionally authorized formal BRAC. This requires that military communities better support their military base to increase its military value. This, in turn, requires expert strategic planning, an understanding of U.S. military and Congressional objectives, as well as business, community, state and local government expertise to map, navigate and implement the best path forward.
