Mr. Sligh served a 24-year U.S. Navy and USCG career, including 10 years as a commissioned officer, deploying multiple times in senior leadership roles to support the USCG's Deepwater Horizon response and to hurricanes Katrina, Rita, Gustav, and Michael.
